## **Advanced Issues in Parenting Coordination: Functional Co-parenting** for High Conflict Families

A two-day training for parenting coordinators, mediators, custody evaluators, attorneys and other professionals who work with high conflict divorcing parents.

The parenting coordination role is becoming a preferred alternative to the legaladversarial process to assist high conflict co-parents implement court-ordered parenting plans. This advanced training provides a conceptual foundation for functional co-parenting, focused structural disengagement, conflict management and creating collaborative systems, and the nuts and bolts of managing these challenging cases.

Participants in this two-day training will:

- Be provided a conceptual model of co-parenting after divorce, derived from the literature on high-conflict divorce;
- Distinguish the elements of the traditional legal-adversarial process that is so toxic to these parents and children;
- Develop a working understanding of the concepts of structural disengagement and parallel parenting as the principle interventions with high conflict co-parents;
- Work through a practical set of procedures to do parenting coordination work with highly conflicted co-parents;
- Identify the utility of working with comprehensive parenting plans as the basis for functional parallel co-parenting;
- Learn principles and procedures in the parenting coordination process to provide intensive training in functional co-parenting;
- Be provided practical materials—orders of appointment, detailed parenting plans, sample documentation, policies and procedures—to help establish a practice in this area; and
- Describe professional practice and ethical issues that can create professional risk for parenting coordinators.

### **About the Presenter**



Matthew J. Sullivan, Ph.D. is a psychologist in private practice who received his undergraduate degree from Stanford University and his doctorate in clinical/ community psychology from the University of Maryland. He has written articles, presented and done trainings at numerous national and international venues on topics such as high-conflict divorce, parenting coordination and child alienation. He is currently serving on the editorial board of the Journal of Child Custody and was a member of the Association of Family and Conciliation Courts Task Force on Parenting Coordination. He was recently appointed to

## The Battle Between Abuse and Alienation: **Assessment, Diagnosis and Interventions**

A two-day training for judges, lawyers, custody evaluators, mediators and other professionals who work with high-conflict families.

Frequently in complex child custody cases the sides line up with allegations of abuse in one corner and allegations of alienation in the other. Often people take sides and they find themselves lost in the battle and in so doing, they lose sight of the children, as it becomes a war between the two A's—abuse and alienation. How do we know the Truth that is behind why a child rejects his or her parent? Once we know that, there is even more to know, and that is what to do about it and how to intervene. This workshop will address these issues, current research, and describe best practices for evaluating these families and the interventions that best serve them.

Participants in this two-day training will:

- Learn how to assess alienation and abuse and to make a distinction between the two;
- Learn where on the continuum of abuse and of alienating behaviors a particular family falls;
- Learn ways to assess for safety issues and how to put the child first;
- Learn ways to help facilitate a "child-centered" custody evaluation;
- Learn how to delineate a child's vulnerabilities and strengths dependent upon his or her age and stage of development;
- Understand the research on abuse and alienation and what we know from it about children, parenting and attachment issues;
- Learn how to apply the AFCC Model Standards, APA's Guidelines for Evaluations of Parenting Responsibility, APA's Specialty Guidelines for Forensic Psychology, and APA's Ethics Code as well as state and local rules of court to cases with these complex issues; and
- Facilitate the creation of interventions in these cases that emphasize accountability, accountability and even more accountability.

**Leslie M. Drozd, Ph.D.** is the editor of the *Journal of Child Custody* and a psychologist in independent practice in Newport Beach, California. She is coauthor of *The Missing Piece: Solving* the Puzzle of Self. Dr. Drozd is also the author, co-author, or coeditor of numerous professional books and articles including Psychological Testing in Child Custody Cases, Child Sexual Abuse Allegations in Child Custody Cases, Relocation Issues in Child Custody, Self as the Mediator in the Psychopathology of Children of Alcoholics; Safety First: A Model for Understanding Domestic Violence in Child Custody and Access Disputes; Is It Abuse, Alienation, and/or Estrangement? Domestic Violence: True or

False, and the National Council of Juvenile and Family Court Judges' Bench Book for Family and Juvenile Court Judges on Navigating Domestic Violence in Child Custody Cases.
