### 1. Custody Evaluations: The Essentials

This full-day institute will address the fundamentals of conducting child custody evaluations. Participants will learn how to prepare to conduct evaluations and will be provided with an extensive review of evaluation methodology, including interviewing skills, using collateral sources, report writing and interpreting test data. Emphasis will be placed on choosing tests that conform to legal standards of admissibility, understanding how a parent's response style affects the confidence and certainty that can be placed in interpretations of the test data, and the use of context-specific normative data in custody evaluations.

### 1. Assessing Children's Perceptions of Family Relationships

A major challenge in conducting child custody evaluations is how to assess children's feelings and thoughts about their divorced parents and other family members in a reliable, valid and useful way. Previous authors have focused on improving questioning techniques. This workshop focuses on a nonverbal and verbal interactive interview instrument, which engages children aged four to twelve. The 80-item instrument systematically elicits positive and negative feelings and perceptions of (1) Closeness and security, (2) Parenting behavior, (3) "Red flag" behaviors, and (4) Co-parenting behavior, with multiple family members. The instrument allows follow-up probes. New data will be presented on reliability and validity with illustrative case studies.

### 2. Mental Health Consultation in Child Custody Cases

As custody disputes become more complex, attorneys more frequently collaborate with mental health professionals to assist their clients. ## 6. Identifying and Working with Severely Disturbed Parents in Child Custody Litigation

This presentation will address how the collaboration of attorney, custody evaluator and child psychotherapist can help high-conflict, characterologically disturbed parents to appropriately utilize the divorce-custody framework. The presentation will demonstrate how to structure the evaluation, make recommendations and coordinate professional services to effect change in the family system, and provide for the best interests of the child. ## 10. Attachment Theory and Research: An Update with Implications for Child Custody Evaluation

Empirical research into attachment theory has often failed to substantiate its tenets. Attachment status early in life has not consistently proved stable over time, nor has it well predicted behavioral outcomes later in life. There have been exceptions, notably disorganized attachment, which tends to predict a poorer outcome. New research, however, has begun to emerge that supports a view of attachment that looks beyond the parent-child dyad in evaluating outcome, and moves beyond infancy as the only reference point for prediction. Solid, often replicated studies of the outcomes of secure attachment have become available and will be described. Implications for child custody evaluation will be discussed.

## 12. Domestic Violence Treatment in a Collaborative Program

This workshop introduces the methods and interventions of the Family Assessment and Intervention Resources (FAIR) program and the underlying research-based rationale. FAIR is a domestic violence family intervention and prevention program. It is an unusual, perhaps unique, collaborative effort between the court and a research university. ## 19. Saving the Baby and Preserving the Father-Child Relationship in Divorce

Controversy over infant parenting plans with fathers has centered on the conflict between the infant's developmental needs and the father's need to develop an early bond with the child that will increase his long term involvement and attachment to the infant. This workshop will explore the outcomes of the Minnesota Longitudinal Study of Parents and Children, recent neurobiological research on right brain development in the infant and current studies regarding the most effective strategies to keep both parents involved in the life of a child. A model will be presented for determining how the infant's developmental needs can be balanced with the father's need to become bonded with the infant in the early years, even if the parents are not together. A program for developmentally sound parenting schedules for infants will be discussed with an emphasis on teaching parents to work together to address the infant's development in the first two years of life in order to facilitate both parent's involvement in the child's life. The impact of early development on ADHD, depression, and anxiety will also be explored.

## 20. Ethical Considerations in Expert Reviews

Attorneys are more frequently asking for experienced custody evaluators to review and critique their colleagues' work and render additional opinions of evaluations performed by court-appointed neutral evaluators. From the viewpoints of two custody evaluators, a family law attorney and a family law commissioner, this session explores the inherently complex set of issues present in such situations. In the process, this panel will address legal, ethical and clinical matters in an effort to define ways in which evaluation reviews can offer input that focuses on the best interests of the child and assists the court in situations rife with conflict and disagreement.

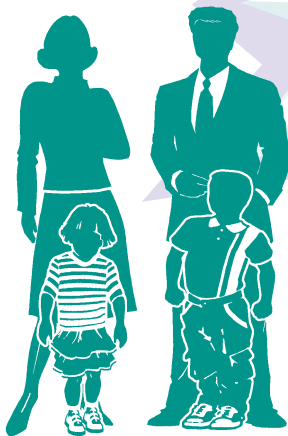
