KEYNOTE SPEAKER

Matthew Sullivan. Ph.D. is a clinical psychologist in private practice in Palo Alto, CA, who specializes in forensic child and family psychology. He is a pioneer in the field of parenting coordination, which he helped develop in Santa Clara County more than 20 years ago, and has led the development of parenting coordination across the U.S. He is one of the most experienced parenting coordinators (called special master in California) in the country. He has published and presented extensively on issues of high-conflict divorce, forensic mental health consultation, parenting coordination, alienation, and courtinvolved therapy. Dr. Sullivan has served on the editorial board of the Journal of Child Custody, the Association of Family and Conciliation Courts' (AFCC) Task Force on Parenting Coordination, and he was the co-chair of the Task Force for Court-involved Therapy, Dr. Sullivan serves on AFCC's Board of Directors for both the international parent organization and for the California Chapter. He won the 2012 Joseph Drown award from California AFCC for "Outstanding Services to Children."
